# Media Consent and Release Form

## 1. Introduction

Grand Challenges Nigeria (“GCNg”) is committed to promoting the innovative work and achievements of its grantees. By signing this Media Consent and Release Form, grantees grant GCNg the right to use their names, likenesses, voices, and biographical information in various media formats, including the internet, social media platforms, printed materials, and other promotional mediums.

## 2. Authorization for Use of Media

**5. Duration and Termination**

This consent and release shall remain in effect indefinitely unless revoked in writing. I understand that revocation of this consent will not apply to media already produced and published after the receipt of my written revocation. **6. Release and Hold Harmless**

I hereby release and hold harmless GCNg, its partners, affiliates, licensees, agents, and assigns from any claims, demands, and causes of action arising out of or in connection with the use of the media, including but not limited to any claims for defamation, invasion of privacy, or infringement of moral rights, rights of publicity, or copyright.
